Data Retention

Data Sharing and Third Parties

We do not sell your personal data. We may share limited data with trusted partners who help operate our business, such as:



- Hosting providers (e.g., Google, Cloudflare)

- Analytics services (e.g., Google Analytics)

These providers only process your data under our instructions and in compliance with GDPR.
